

We are registered with the U.S. Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services fees differ and it is important for you to understand the differences. What investment services and advice can you provide me?

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A (“Disclosure Brochure”). Our services to retail investors include the following: financial planning and consulting; investment management and wealth management; and investment, institutional, and business consulting services. As part of our standard services, we monitor investments that we manage on a continuous and ongoing basis. Financial planning and investment consulting recommendations are not actively monitored. There are no material limitations to our monitoring. We accept discretionary and/or non-discretionary authority to implement the recommended transactions in client accounts. The level of discretion is determined in our agreement and there are no material limitations on the authority. For non-discretionary services, you make the ultimate decision regarding the purchase or sale of investments. We do not offer advice only with respect to proprietary products. We primarily offer advice on mutual funds, exchange-traded funds (“ETFs”), and independent investment managers (“Independent Managers”). We may also advise on individual debt and equity securities, options, alternative investments, real estate investment trusts, and master limited partnerships. Our services are subject to a minimum fee of \$5,000. Resonant may, in its sole discretion, elect to waive its minimum fee.

What fees will I pay?

We offer our services on a fee basis. We charge a fixed or hourly fee for financial planning and consulting services, as well as for institutional and business consulting services. We charge a fee based on assets under management for investment management services. We charge either a fee based on assets under management or a fixed fee for wealth management services. Finally, we charge a fee based on assets under management for investment consulting services. For project-based services, one half of the fees are due upon engaging us while the remainder is due upon delivery of the services. For ongoing services, the annual fee is prorated and charged quarterly.

In addition to the advisory fees being paid to us, certain additional charges might be imposed by other third parties, including broker-dealers and custodians. Examples of possible additional charges include securities brokerage commissions, mark-ups and mark-downs on fixed-income transactions, other transactions costs, custodial fees, fees attributable to alternative assets, reporting charges, fees charged by the Independent Managers, charges imposed directly by a mutual fund or ETF in a client’s account, as disclosed in the fund’s prospectus (e.g., fund management fees and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

The more assets that are in your advisory account, the higher the fees you will pay, and conversely, the fewer assets that are in your advisory account, the lower the fees you will pay. The firm may therefore have an incentive to encourage you to increase the assets in your account. You will pay fees whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure that you understand what fees and costs you are paying.

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- Support from Custodian: We receive administrative support, computer software, related systems support, as well as other third party support from the custodian that we recommend. This results in an incentive to recommend that custodian because we do not have to produce or pay for the products or services provided.

How do your financial professionals make money?

Our financial professionals are compensated based on the following factors and conflicts of interest:

- The amount of client assets they service. This results in an incentive to favor clients with more assets being serviced.
- Revenue the firm earns from the financial professional's advisory services or recommendations. This results in an incentive to take steps to maximize revenue to the firm.
- The complexity and time required to meet the client's needs in engagements in which fees are tied to billable time. This results in an incentive to spend more time on issues than is required.
